#### **NATIONAL NEWS**

- 1. Raksha Mantri Rajnath Singh approves capital acquisition proposals worth Rs 2.23 lakh crore to boost Indian Defence Industry
- Defence Acquisition Council headed by Raksha Mantri Rajnath Singh approved capital acquisition proposals worth 2 lakh 23 thousand crore rupees to enhance the operational capabilities of the Armed Forces
- Defence Ministry, 98 per cent of the total amount will be sourced from domestic industries.
- This will give a substantial boost to the Indian Defence Industry with the aim of achieving the goal of Aatmanirbharta.
- The Council has approved the procurement of two types of Anti-tank Munitions namely, Area Denial Munition (ADM) Type-2 and Type-3, which are capable of neutralising Tanks and Armoured personnel carriers and enemy personnel.
- 2. World's first portable hospital 'Aarogya Maitri Aid Cube' unveiled in Gurugram
- The World's first portable hospital, 'Aarogya Maitri Aid Cube' was unveiled in Gurugram.
- Designed indigenously under the Project 'BHISHM', the modular trauma management and aid system is made up of 72 detachable mini-cubes, each being a specialized station for emergency response and humanitarian efforts.
- It can handle bullet injuries, burns, head, spinal and chest injuries, minor surgeries, fractures and major bleeding.
- These cubes are light and portable, and can be rapidly deployed anywhere, from airdrops to ground transportation.
- 3. PM launches Green Credit Initiative at COP28 climate conference aimed at reshaping global environmental policies
- Prime Minister Narendra Modi launched the 'Green Credit Initiative,' a pathbreaking program aimed at reshaping global environmental policies.
- He also launched the official portal of the Green credit initiative at COP28.



- The Prime Minister highlighted the limitations of the current carbon credit system, influenced by commercial interests and lacking a sense of social responsibility, paving the way for a new philosophy embodied in the 'Green Credit' concept.
- Ulf Kristersson, Prime Minister of Sweden, praised the initiative, citing Sweden's success with the Climate Leap, reducing climate emissions by 3.3 million tonnes per year through collective action.

## 4. Indian Railways allows MNCs to deploy indigenous Kavach anti train collision system on network

- India's ability to deploy automatic train collision avoidance systems Kavach is expected to get a fillip with global companies getting approvals to install it on the national transporter
- Germany's Siemens and Japan's Kyosan are the two new approved Kavach deployment companies.
- Railways Minister Ashwini Vaishnaw Kavach deployment will increase to 5000 kilometers (kms) per annum in the financial year 2025-26, up from 1500 kms annually.

#### 5. Cabinet approves Terms of Reference for the Sixteenth Finance Commission.

- The Union Cabinet chaired by the Prime Minister, Shri Narendra Modi has approved the Terms of Reference for the Sixteenth Finance Commission.
- The Terms of Reference for the Sixteenth Finance Commission will be notified in due course of time
- The 16th Finance Commission's recommendations, upon acceptance by the government, would cover the period of five (5) years commencing April 1, 2026.
- Article 280(1) of the Constitutions lays down that the modalities for setting up of a Finance Commission to make recommendation on the distribution of net proceeds of taxes between the Union and the States, allocation between the States of respective shares of such proceeds; grants- in-aid and the revenues of the States and measures needed to supplement the resources of the Panchayats during the award period.
- The Fifteenth Finance Commission was constituted on November 27, 2017.



- 6. Union Minister for Power RK Singh inaugurates National Conference on "Energy Transition in India in Gandhinagar
- Union Minister for Power and New and Renewable Energy Shri R.K. Singh inaugurated a two-day National Conference on "Energy Transition in India -Road Travelled and Opportunities Ahead" in Gandhinagar.
- Shri Kanubhai Desai, Minister of Energy Petrochemicals and Finance, Government of Gujarat was also present along with other dignitaries on the occasion.
- Organized as a part of the upcoming Vibrant Gujarat Global Summit 2024, the event is being attended by more than 250 Indian and foreign representatives of power and renewable energy sector.

#### 7. Unemployment rate dips to 6.6 pc in Sep quarter

- According to the Periodic Labour Force Survey (PLFS), the unemployment rate in urban areas has decreased from 7.2% in July-September, 2022 to 6.6% in July-September 2023.
- The unemployment rate was 6.6% for persons under the age of 15 years
- For persons aged 15 years and above, the worker-population ratio (WPR) in urban areas has increased from 44.5% in July-September, 2022 to 46% in July-September, 2023.
- For the male category, it has increased from 68.6% to 69.4% while it has increased from 19.7% to 21.9% for women during this period.

## 8. India re-elected to International Maritime Organisation with the highest vote tally.

- In elections held at its assembly for the 2024–25 biennium, India was re-elected to the International Maritime Organisation (IMO) Council with the highest tally.
- India's re-election falls under the Category of 10 states with "the largest interest in international seaborne trade", alongside Australia, Brazil, Canada, France, Germany, the Netherlands, Spain, Sweden, and the United Arab Emirates (UAE).
- India has been elected in the category of ten countries with the largest interest in international seaborne trade.
- The term of the Council will be for the biennium 2024-25.



- India's re-election shows the government's commitment to enhance India's diverse.
- 9. India will be the largest cotton producer.
- According to the Union Minister for Textiles Commerce and Industry, India will strive to become the largest cotton producer globally.
- He was inaugurating an annual global meeting the 81st plenary session of the International Cotton Advisory Committee (ICAC) a UN recognised body of cotton producing and consuming nations.
- Cotton is one of the most important commercial crops cultivated in India and accounts for around 25% of the total global cotton production.
- India has the largest area under cotton cultivation and is the second largest producer (after China).



#### INTERNATIONAL NEWS

- 1. Nepal Achieves Milestone as the First South Asian Nation to Legally Recognize Same-Sex Marriage.
- Nepal has become the first South Asian country to officially register same-sex marriage.
- The marriage between 36-year-old Ram Bahadur (Maya) Gurun and Surendra Pandey has been registered in Nepal.
- The registration of same-sex marriage in Nepal is facilitated by an interim order from the Supreme Court, which supports the legal recognition of marriages between same-sex couples.
- 2. Pakistan Secures Vice Chair Post at UNESCO with a 10-Vote Lead Over India.
- Pakistan secured a significant victory over India in the UNESCO executive board election for the post of vice-chair.
- The Pakistani candidate received 38 votes, while the Indian candidate received only 18.
- Pakistan's victory of being elected as vice chair of the UNESCO Executive Board for 2023-2025 from the Asia Pacific Group, is being seen as a major setback for Indian diplomats in the UN.
- 3. India-Sweden Industry Transition Partnership, LeadIT 2.0 Launched at COP28 Dubai
- India and Sweden launched Leadership Group for Industry Transition (LeadIT)
   2.0 during the COP28 World Climate Action Summit, hosted in Dubai for the period 2024-26, at COP-28 in Dubai.
- LeadIT was initially co-launched by India and Sweden at the UN Climate Action Summit in New York in 2019.
- LeadIT has grown into a collaborative effort involving 18 countries and 20 industry-leading companies.
- The LeadIT initiative, initially centred around pivotal sectors such as iron, steel, cement, and aluminium, focused on industry transition and knowledge sharing.



- 4. 18 Countries Back New Global Guidelines, Crafted by the US and UK, to Enhance Cybersecurity in Artificial Intelligence (AI).
- 18 countries endorsed new global guidelines, developed by the United States (US) and the United Kingdom (UK), to make artificial intelligence (AI) "secure by design" and "raise the AI cybersecurity bar.
- The Guidelines for Secure AI System Development deal with secure design, development, deployment and operation and maintenance of AI systems.
- The guidelines were formulated by the UK's National Cyber Security Centre (NCSC) and the US's Cybersecurity and Infrastructure Security Agency (CISA).
- They aim to "raise the cybersecurity levels of artificial intelligence and help ensure that it is designed, developed, and deployed securely.
- 5. Pakistan Submits BRICS Membership Application in 2024.
- Pakistan has filed an application to join the BRICS group of nations in 2024 and is counting on Russia's assistance during the membership process.
- Pakistan's application came as the grouping of emerging economies was set for its biggest expansion with 6 new members under Russia's rotating Presidency in 2024.
- New Members: Argentina, Egypt, Ethiopia, Iran, Saudi Arabia, and the United Arab Emirates (UAE) as new members formally admitted to the BRICS summit-2023 held in South Africa.
- However, they will formally join during the 2024 summit in Kazan, Russia.
- 6. The UAE announced a US\$30 billion commitment to the newly launched catalytic climate vehicle, ALTÉRRA.
- With this US\$30 billion commitment, ALTÉRRA becomes the world's largest private investment vehicle for climate change action and will aim to mobilize US\$250 billion globally by 2030.
- It aims to steer private markets towards climate investments and focus on transforming emerging markets and developing economies, where traditional investment has been lacking due to the higher perceived risks across those geographies.



 ALTÉRRA has been established by Lunate, an independent global investment manager, and is domiciled in the Abu Dhabi Global Market.

## 7. India to Extend \$250 Million Line of Credit to Kenya for the Modernization of its Agricultural Sector

- India has committed a \$250 million Line of Credit to Kenya for the modernization of its agricultural sector.
- The announcement came following talks between Indian Prime Minister Narendra Modi and Kenyan President William Samoei Ruto.
- Modi and Ruto discussed and agreed to strengthen bilateral ties in various sectors, including defence, trade, energy, digital public infrastructure, and healthcare.

#### 8. Italy withdraws from China's Belt and Road project

- Italy has officially pulled out of China's Belt and Road infrastructure initiative, making this move more than four years after initially joining as the sole G7 nation to do so.
- Italy had initially signed an agreement to join the BRI in 2019.
- However, after 4 years, the expected benefits did not materialize for Italy.
- The agreement with China was supposed to be automatically renewed after expiring in March 2024, unless Rome gave at least three months' written warning of pulling out.
- Chinese FDI in Italy dropped from \$650 million in 2019 to just \$33 million in 2021.

## 9. Argentina's Entry into BRICS Postponed; Not Joining Developing Economies Bloc Next Year as Planned.

- Argentina's entry into the BRICS bloc of developing economies, originally scheduled for January 1, 2024, has been postponed.
- The decision is seen as a precursor to a significant foreign policy shift in Argentina under the leadership of right-wing populist Mr. Milei, indicating potential changes in diplomatic priorities.



- Argentina was one of six countries invited in August to join BRICS, comprising Brazil, Russia, India, China, and South Africa.
- The move aimed to expand the bloc to an 11-nation alliance.

## 10. Garba Dance from Gujarat Recognized as UNESCO's 'Intangible Cultural Heritage'

- The United Nations Educational, Scientific and Cultural Organization (UNESCO) approved the inclusion of garba, Gujarat's most popular folk dance form, in its Representative List of Intangible Cultural Heritage (ICH) of Humanity.
- A decision to "inscribe" the dance form as "intangible heritage" was taken at the 18th session of UNESCO's Intergovernmental Committee for Safeguarding of Intangible Cultural Heritage held in the Republic of Botswana.
- With this, 15 elements from various parts of India have been inscribed to UNESCO's representative list of ICH.



#### **ECONOMICS**

#### 1. India Records Near 5-Year High Banking Liquidity Deficit

- India's banking system liquidity deficit has widened to the highest in nearly 5 years on monthly goods and services tax payments.
- The liquidity deficit is the amount of funds banks need to borrow from the interbank market or from the central bank.
- Liquidity in the banking system refers to readily available cash that banks need to meet short-term business and financial needs.
- According to the Reserve Bank of India (RBI), the liquidity deficit stood at Rs 1.74 lakh crore (\$20.90 billion). **HDFC Bank Introduces Three New Digital Payment Products on UPI.**
- HDFC Bank has introduced 3 new digital payment products on the Unified Payment Interface (UPI).
- These products are UPI 123Pay: Payment via IVR (Interactive Voice Response), UPI Plug-In Service for Merchant Transactions, AutoPay on QR codes.
- UPI 123Pay enables users to make payments using a phone call, without requiring internet connectivity or a smartphone.
- AutoPay on QR enables recurring payments through UPI QR and aims to transform various use cases, including Over-The-Top (OTT) platforms, audio subscriptions, newsletters, and other digital subscription services.

#### 2. SEBI Grants Approval to Jana Small Finance Bank for IPO.

- Jana Small Finance Bank, backed by TPG Capital, has received approval from the Securities & Exchange Board of India (SEBI) for its initial public offering (IPO).
- The IPO comprises a fresh issue of equity shares worth Rs 575 crore with a face value of Rs 10 each
- Additionally, there is an offer for sale of up to 4.05 million shares by existing shareholders and promoters.
- Jana Small Finance Bank, upon successful listing, will become the 7th small finance bank (SFB) to be listed on the stock exchange.



#### 3. Private general insurers expand market share to 53.58% in H1 FY24.

- Private general insurers increased their combined market share to 53.58% in gross direct premium underwritten in the first half of the current financial year from 50.81% in the year-ago period.
- As many as 31 insurers from the non-life industry had underwritten gross direct premiums of Rs 1.43 lakh crore in the first half of the current financial year, according to data on segment-wise gross direct premiums up to September 2023 released by Insurance Regulatory and Development Authority of India (IRDAI).
- Private insurers registered an annual increase of 14.86% in gross direct premiums.
- The non-life industry recorded a gross direct premium (GDP) of Rs 1,25,194 crore in the AprilSeptember period of the previous financial year (2022-23).

#### 4. What is the Corporate Debt Market Development Fund (CDMDF)?.

- CDMDF is an alternative investment fund designed to address the requirements of the corporate debt market in India.
- It will be launched as a close-ended scheme, indicating a fixed tenure for its operation.
- CDMDF serves as a backstop facility specifically for investment-grade corporate debt securities.
- Its primary function is to provide stability and boost investor confidence in the corporate debt market.
- CDMDF provides a backstop facility of Rs 33,000 crore has been established for Mutual Funds.

#### 5. Insurance Ombudsman Resolves 92% of Complaints in FY23.

- The insurance ombudsman disposed of over 92% of the complaints it received from the insured during 2022-23.
- It received 55,946 complaints during the year across its offices in the country, of which 51,625 were disposed of.
- The Delhi centre disposed of all the 5,257 complaints it got during the year, according to a press statement issued by the Delhi office of the Insurance Ombudsman.



- The offices of the Insurance Ombudsman are under the administrative control of the Council for Insurance Ombudsman (CIO).
- 6. BharatPe Achieves Ebitda Positivity for the First Time in October, Achieves Annual Recurring Revenue (ARR) of Rs 1,500 Crore.
- Fintech major BharatPe turned Ebitda-positive in October and clocked an annualised revenue of Rs 1,500 crore, up 31% from the year-ago period, on the back of a significant growth in lending and payments business
- The company also reduced its cash burn, which was averaging Rs 60 crore a month in FY23, to attain a positive Ebitda.
- EBITDA, or earnings before interest, taxes, depreciation, and amortization, is an alternative measure of a company's overall financial performance.
- 7. RBI Monetary Policy : Repo rate kept unchanged at 6.5%, FY24 GDP estimate hiked to 7%
- The Reserve Bank of India's Monetary Policy Committee (MPC) kept the reporate unchanged for the fifth time in a row at 6.5%.
- The real GDP growth projection for the fiscal year 2023-24 has been revised upward to 7% from the previous estimate of 6.5%.
- The inflation forecast for the fiscal year 2023-24 remains unchanged at 5.4%.
- The policy repo rate under the liquidity adjustment facility (LAF) has been kept steady at 6.50%.
- The standing deposit facility (SDF) rate is maintained at 6.25%, and the marginal standing facility (MSF) rate, along with the Bank Rate, remains at 6.75%.
- 8. RBI to Develop Regulatory Framework for Oversight of Loan Aggregators
- The Reserve Bank of India (RBI) announced that it will soon release a regulatory framework aimed at overseeing web-based loan comparison platforms known as web-aggregators of loan products (WALP).
- WALP offers the service of aggregating loan offers from multiple lenders on an electronic platform which allows borrowers to easily compare different offers and choose the most suitable loan option available from the participating lenders.



- Objective of the Framework: The RBI aims to create a structured system for loan aggregation services provided by lending service providers (LSPs).
- The framework aims to enhance transparency in the operations of WALPs or digital lending.
- It focuses on increasing customer centricity and enabling borrowers to make informed choices.

#### 9. UPI Transaction Value Hits Record ₹17.4 Lakh Crore in November 2023

- Unified Payments Interface (UPI) transaction value reached a new high level at ₹17.4 lakh crore in November 2023.
- UPI transaction volume declined slightly to 1,124 crore from 1,141 crore in October.
- UPI transaction value was ₹17.16 lakh crore in October.
- UPI transactions fell slightly by 1.5% to 1,124 crore from 1,141 crore in October.



#### SCIENCE AND TECHNOLOGY

- 1. IndiGo Introduces AI Chatbot 6Eskai for Assistance in Flight Booking, Web Check-in, and Discount Information.
- In a significant leap forward in the realm of Indian aviation, IndiGo, the country's largest airline, has unveiled a cutting-edge AI chat assistant, 6Eskai, powered by GPT-4 technology.
- This innovative chatbot, developed in collaboration with Microsoft, is poised to reshape the passenger experience by efficiently handling customer queries in 10 different languages.
- To begin with, it will address customer queries in 10 different languages.
- Early results show a 75% reduction in customer service agent workload.

#### 2. Google Delays Launch of Next-Gen AI Model Gemini to 2024

- Google has quietly pushed back the launch of next-gen AI model Gemini until 2024.
- Gemini is touted as Google's most sophisticated artificial intelligence model.
- Gemini has been stated to strongly outperform OpenAI's GPT-4 as it harnesses vastly more computing power than its competitor.
- Gemini is reported to strongly outperform OpenAI's GPT-4, emphasizing its superior computing capabilities.

#### 3. Saturn's Rings Will Temporarily Disappear From View in 2025

- In 2025, Saturn's rings will seemingly disappear from Earth's view due to the phenomenon known as the "Saturnian equinox."
- The Saturnian equinox occurs when the Sun crosses Saturn's equator, resulting in approximately equal durations of day and night on the planet.
- Saturn experiences equinoxes roughly every 15 Earth years due to its extended orbital period.

#### 4. China Establishes World's First 'Near-Space Command

• China has established the world's first near-space command, which is the fifth branch of the People's Liberation Army (PLA), focusing on the development of hypersonic weapons.



- The near-space command operates in the near-space area, ranging from an altitude of 20 km to the lower boundary of space at 100km.
- Equipped with hypersonic missiles, the near-space command is designed to target critical military assets and conduct high-altitude surveillance globally using automated drones and spy balloons
- Hypersonic weapons possess speeds of at least Mach 5, making them highly maneuverable and capable of changing course during flight.
- The term "Mach" is a unit of measurement representing the speed of a moving object relative to the speed of sound.
- Search giant Google in consultation with the National Disaster Management Authority (NDMA) and the National Seismology Center (NSC) and the Ministry of Earth Sciences has launched its Earthquake Alerts System for Android smartphone users in India.
- 5. Denmark museum allows Bluetooth inventors to use Viking king's name for 1,000 NASA Unveils Initiative to Send ISRO-Selected Indian Astronaut to International Space Station by 2024.
- US space agency National Aeronautics and Space Administration (NASA) plans to train an Indian astronaut for a mission to the International Space Station (ISS) by the end of 2024.
- Bill Nelson, the administrator of NASA, made this announcement during his visit to Delhi, India.
- A major collaboration between India and the United States is the NISAR satellite, set to be launched in the first quarter of 2024.
- 6. Voice Over 5G Or Vo5G Is Gradually Replacing VoLTE Across The Globe.
- Vo5G/VoNR is the future standard for voice calling that operates over 5G networks, providing improved speed, capacity, and responsiveness compared to 4G networks
- It leverages the capabilities of 5G networks, aiming to enhance voice calling experiences through higher quality, reduced latency, and better reliability.
- VoNR aims to provide superior voice quality, clearer audio, and reduced latency compared to previous voice technologies like VoLTE.



- VoNR operates using the 5G Core (5GC) network architecture, which provides a more flexible and scalable framework for delivering voice services.
- It supports modern codecs like EVS (Enhanced Voice Service) and AMR-WB (Adaptive Multi-Rate Wideband), enabling high-definition voice calling.

## 7. Indian Immunologicals Launches Measles and Rubella Vaccine Catering to Children.

- The measles and rubella vaccine "Mabella" was launched by Vaccine maker Indian Immunologicals (IIL) for children.
- The live-attenuated MR vaccine, Mabella, was developed through an exclusive partnership with the Polyvac Institute of Vietnam.
- Mabella was launched as part of the 25th celebrations of the IIL division Human Biologicals Institute (HBI) in Udhagamandalam (Ooty), Tamil Nadu (TN).
- The vaccine has been proven to be safe and effective through extensive human clinical trials.

## 8. NASA's Solar Probe Achieves Record as Fastest Man-Made Iran Reveals Upgraded Karrar Drones Equipped with Air-to-Air Missiles.

- Iran unveiled advanced Karrar combat drones armed with air-to-air missiles, enhancing its air defence capabilities.
- It is an Unmanned Combat Air Vehicle (UCAV) developed by Iran.
- It is the first long-endurance, combat-capable Iranian drone.
- The Karrar drone, which was first introduced in 2010, has an operational range of up to 1,000 kilometres (620 miles).
- It has a maximum speed granted by its turbojet installation of 560 miles per hour.
- It reportedly boasts a service ceiling altitude of 47,000 feet.

## 9. ISRO to launch Chandrayaan-4 to bring back samples from Moon in 4 yrs: - Chairman Somanath.

• The Indian Space Research Organisation (ISRO) has planned to launch Chandrayaan-4 to bring back samples from the Moon in 4 years stated its chairperson S Somanath while elaborating on the space agency's Vision 2047.



- The first module of the Bharatiya Antariksh Station India's planned space station, that will be capable of conducting experiments with the help of robots will be launched by 2028.
- Prime Minister Narendra Modi had previously called on the space agency to set up a space station by 2035 and send a man to the Moon by 2040.
- Bharatiya Antariksh Station is India's planned space station.
- The SPADEX experiment will demonstrate autonomous docking capability
- In the process known as docking, two spacecraft are aligned in a precise orbit and joined together.
- ISRO has shown how to use leftover fuel from the propulsion module to return a spacecraft from the Moon to Earth orbit.
- The Next Generation Launch Vehicle (NGVL), being designed by ISRO, will be able to transport 16 to 25 T into low Earth orbit.

#### 10. Meta Collaborates with ONDC to Bolster Small Businesses in India.

- Meta, a prominent technology company, has entered into a collaboration with the governmentbacked ecommerce network Open Network for Digital Commerce (ONDC).
- To provide support and upskilling opportunities for small businesses in India, leveraging Meta's business and technical solution providers.
- Enhanced Buyer-Seller Experiences: Meta's involvement includes the deployment of its business and technical solution providers to enhance conversational experiences between buyers and sellers on WhatsApp, a Metaowned platform.
- ONDC's Role in Business Transformation: ONDC will play a crucial role in assisting businesses to become seller apps and facilitating their onboarding onto the network, contributing to the digitization and transformation of these enterprises.
- Meta Small Business Academy: The Meta Small Business Academy is introduced
  as part of the initiative, offering certification programs for entrepreneurs and
  marketers. These programs focus on imparting digital marketing skills essential
  for growth on Meta's platforms, including WhatsApp, Facebook, and Instagram.



#### **DEFENCE**

- 1. Ministry of Defence inks deal with Agnit Semiconductors.
- The Ministry of Defence (MoD) has signed a contract with Agnit Semiconductors Private Limited for design and development of advanced Gallium Nitride (Gan) semiconductors essential for the next generation of wireless transmitters in defence applications ranging from radars to electronics warfare jammers.
- This contract marks the 300th agreement under the Innovations for Defence Excellence (iDEX) initiative of the Defence Innovation Organisation (DIO).

#### TRANSLATION- ENGLISH

- 1. We are concerned in this appeal only with the conviction of the appellant under section 324 read with section 123-B of the IPC. The case of Prosecution as against the appellant, in short, is that PW-4 had purchased the said auto rickshaw from Jaina Automobiles on 11-7- 1997. he had entered into a hire purchase agreement (M.O. 4) with City Auto Finance of which the appellant is the Managing Partner. There was default in the payment of instalments, and this had infuriated the appellant. Therefore according to the Prosecution on 25-3-1999 at about 12 noon in Moovattupuzha, the appellant had entered into a criminal conspiracy with A1 to A3, who were engaged in the profession or vehicle seizure, to repossess the said auto rickshaw by hook or by crook irrespective of the consequences that may follow and, in pursuance of the said criminal conspiracy, on 31-3-1999, A1 to A3 under the pretext or going for a trip, hired the said auto rickshaw and at about 10.30 p.m., murdered Binay, the driver and took away the said auto rickshaw.
- 2. The aforestated cheques, which had been given by Munish Jain as Director of M/s. A.T. Overseas Ltd. had not been honored and due to dishonour of the said cheques, the complainant namely. Anil Sachar, as a partner of M/s. Rati Woolen Mills had issued notice as required under the provisions of section 138 of the Negotiable Instruments Act (have matter referred to as the act) Inspite of the said notice, the complainant was not paid the amount covered under the aforestated cheques and, therefore, complaints had been filed against the present respondents.
- 3. Extra-Judicial confession made by A-1 Pratham is the main plank of the prosecution case. It is true that an extra judicial confession can be used against its maker, but as a matter caution, courts look for corroboration to the same from other evidence on record. In Gopal Shah Vs. State of Bihar, (2008) 17 SCC 128, this court while dealing with an extra-judicial confession is on the face of it a week evidence and the courts are reluctant in the absence of chain of cogent



circumstances to rely on it for the purpose of recording a coveting. We must therefore first ascertain whether extra-judicial confession of A-1. Pratham inspires confidence and them find out whether there are other cogent circumstances on record to support it.

- 4. On notices being issued Respondent No. 1 and 2 driver and owner of the truck respectively remained absent despite due service. Thus they were proceeded exparte. Written statement was field only by Respondent No. 3, the Insurance Company. But the respondents did not lead any evidence in rebuttal to the evidence led by the Appellant. Even the driver of the truck did not enter the Witness Box to deny the Factum of the accident.
- 5. It is well settled that delay in lodging FIR cannot be grounded to doubt the claimants case. Knowing the Indian condition as they are, we cannot expect a common man to first rush to the police station immediately after an accident. Human nature and family responsibilities occupy the mind of kith and kin to such an extent that they give more importance to get the victim treated latter than to rush to the Police Station. Under such circumstances, they are not expected to mechanically with Promptitude in lodging the FIR with the police. Delay in lodging the FIR thus, cannot be the ground the deny justice to the victim. In cases of delay, the courts are required to examine the evidence with a closer scrutiny and in doing so the contents of the FIR should also be scrutinized more carefully. If court finds that there is no indication of Fabrication or it has not been concocted or engineered to implicate innocent persons them even if there is a delay in lodging the FIR the claim case cannot be dismissed merely on that ground.

### **CASE ANALYSIS**

#### 1. Mohit Singhal v. State of Uttarakhand 2023 LiveLaw (SC) 1035

**Facts:** The case revolved around the suicide of the deceased, Ashok Kumar, allegedly due to threats, assault, and a financial dispute between him and the first appellant, the son of a money lender, Sandeep Bansal. In this case, the widow of the deceased had borrowed a sum of Rs.40,000 from Sandeep Bansal and later another sum of Rs.60,000. The deceased was allegedly under tension due to a legal notice issued by Sandeep regarding dishonored cheques. The deceased, distressed by the events, purportedly committed suicide on July 4, 2017. The prosecution relied on a suicide note written by the deceased on June 30, 2017. The High Court, rejected the plea to quash the offence, allowing the case to proceed.

**Question Involved**: The question before the court was whether the appellants instigated the deceased to commit suicide?

**Law Applied**: The Court scrutinized Sections 306 and 107 IPC, emphasizing that for abetment, there must be a specific act of instigation with mens rea, pushing the deceased to a point where suicide becomes the only option.

**Analysis**: In the present case, taking the complaint of the third respondent and the contents of the suicide note as correct, it is impossible to conclude that the appellants instigated the deceased to commit suicide by demanding the payment of the amount borrowed by the third respondent from her husband by using abusive language and by assaulting him by a belt for that purpose."

The Court opined "The said incident allegedly happened more than two weeks before the date of suicide. There is no allegation that any act was done by the appellants in close proximity to the date of suicide. By no stretch of the imagination, the alleged acts of the appellants can amount to instigation to commit suicide."



Held: Therefore, it concluded that the acts of the accused, as described, did not amount to instigation under Section 306. The Court allowed the appeal and quashed the summoning order, observing that the continuation of the prosecution will be "nothing but an abuse of the process of law."

## 2. In Re Article 370 of the Constitution of India 2023 LiveLaw (SC) 1050 Facts:


The validity of the J&K Reorganisation Act 2019, which bifurcated the State of J&K into Union Territories of J&K and Ladakh, was one of the issues before the Court. However, the Court did not rule on this issue in view of the submission of the Solicitor General of India that the statehood of J&K will be restored as soon as possible.

**Issue raised:** whether an entire State could be turned into a Union Territory as per Article 3 was left open.

**Held:** The court also directed that steps shall be taken by the Election Commission of India to conduct elections to the J&K assembly by September 30, 2024. Further, it stated that the restoration of statehood shall take place as soon as possible.

Court upheld the creation of Ladakh UT as valid, holding that Article 3 of the Constitution gave the power to the Parliament to carve out a Union Territory from a State.


